**Work in Progress:**

*Un©ertainty and Dis©omfort*; This essay is now nearing completion. It explores the creative and legal challenges surrounding creative endeavors that embody silence, invisibility, motionlessness, or other strange but expressive meanderings of the human mind. It also discusses the ways in which people with limitations of sight, hearing, or other senses perceive creativity and the contours of copyright law that might be altered to better cope with such sensory issues.

Plans for the next project are in flux, but it will probably grapple with the history, culture, and legal issues surrounding an old, classic copyright case.

 [During my third year in law school I was the law review editor who finalized the publication of this massive data-based court study organized by students who graduated a year before me. I made a number of content changes and added a collection of new data tabulations. The data additions were framed to more fully reveal the enormous scale of racism revealed by the study. I also drafted an “editorial” about my findings and encouraged the editorial board on which I sat to publish it as a preface to the study itself. The board agreed. The journal’s student editors therefore took the rare step of editorializing about an article it published. See *Editorial Note*, 35 U. CHI. L. REV. 256 (1968).
