# **Professor of Law from Practice: Legal Practice Program**

New York Law School (NYLS) invites applications for a full-time position in our Professor of Law from Practice program. The selected candidate will teach our Legal Practice course—a foundational seven-credit, two-semester course that all students take in their first year. Through client-centered simulations and assignments (using New York-based actors in the roles of clients and witnesses), the course introduces students to fundamental lawyering skills in context, including critical reading, legal analysis, predictive and persuasive writing, legal research, client interviewing, counseling, negotiation, and oral advocacy.

The position commences on July 1, 2024, and ends on June 30, 2025, with a possibility of renewal. The full-time position includes teaching two sections of Legal Practice (a total of approximately 40 students between both sections) in both the fall and spring semesters. Professors of Law from Practice work collaboratively to design classes and prepare simulations, writing assignments, and other course materials.
