The Director will be an integral member of the Office of Institutional Advancement and will report to the Associate Dean and Vice President for Institutional Advancement and Chief Development Officer. To achieve top results each year, the Director will work closely with a variety of partners within the Offices of Institutional Advancement, Marketing and Communications, and across the School. A successful candidate will thrive in a fast-paced and high-performing environment and will be nimble and eager to support colleagues in advancing the mission of the School and Office.

- Design the overall strategic, creative, and organizational direction for the NYLS Fund
- Develop and oversee a comprehensive fundraising plan and appeal schedule
- · Grow the John Marshall Harlan II Society and actively engage and steward members
- Manage a portfolio of approximately 75–100 annual leadership prospects
- Partner with the Office of Marketing and Communications to create and execute direct mail/email annual solicitations and dynamic Giving Tuesday and Giving Day campaigns
- Recruit and support volunteers to strengthen reunion and Giving Day efforts
- · Monitor and report on the activity, progress, and achievement of the NYLS Fund
- Inform annual budget process and explore new strategies to maximize ROI
- Work with key internal and cross-departmental partners to enhance engagement, solicitation, and stewardship efforts
- Represent the Office of Institutional Advancement and its priorities, as well as the School's interests and mission, in internally and externally facing meetings and events
- Perform other duties as assigned

Requirements

- Bachelor's degree with at least five or more years of fundraising experience, preferably in an institution of higher education and/or with the legal community
- · Proven track record of raising four and five-figure gifts
- Excellent planning and organizational skills with an ability to prioritize and manage multiple tasks
- Customer-service oriented professional who is highly responsive to donor, staff, and volunteer needs

- Sensitivity to the needs of diverse and multicultural constituencies and interest and aptitude in working within a diverse community
- Solution-oriented performer with an attention to detail and a high level of productivity
- Superior written and oral communication skills
- Evidence-based decision-maker with strong analytical skills
- Excellent interpersonal skills and a high level of professionalism with an ability to work both independently and collaboratively
