For the first position, we are accepting applications from candidates whose teaching and scholarly interests include corporations (including corporate governance), securities regulation, and commercial law. Ideal candidates will also have several years of experience in one of these practice areas.

For the second position, we are accepting applications from candidates whose teaching and scholarly interests focus on the connections between business law and technology, including corporations, fintech, venture capital, entrepreneurship, and other courses related to evolving forms of business organization and financing.

Within the field of **criminal law**, we are seeking one candidate who will teach the first-year criminal law course, criminal procedure, and other specialized topics. In addition to strong scholarly interests in criminal law, the ideal candidate will have several years of experience in this practice area.

New York Law School seeks exceptional candidates who will advance our mission of preparing lawyers committed to the rule of law and the highest standards of the legal profession. We believe that diverse viewpoints, backgrounds, and experiences strengthen legal education and the profession itself—enriching classroom discussions, challenging untested assumptions, and better preparing our graduates to serve all communities in need of legal assistance.
